

Eligible Postcodes for AGN’s 2024 Natural Gas Rebates (Cashback) Promotions

AGN’s 2024 Natural Gas Rebate (Cashback) Promotion launched on 1 April 2024, with offers available until 31 December 2024 to customers who are connected (or are connecting) to the natural gas reticulation system (network) owned by Australian Gas Networks in South Australia, Queensland, New South Wales, and the Northern Territory. Further Terms and Conditions apply. The 2024 Campaign is not currently open to AGN customers in Victoria.

Tables 1-3 in this document can be used to determine offer eligibility in New South Wales and in Queensland, where AGN is not the sole natural gas distributor. Some postcodes have multiple distributors, so customers in these postcodes should confirm address eligibility by contacting AGN’s Customer Service Team on 1300 001 001 (Option 3) or AGN’s Natural Gas Marketing Team on 1300 001 001 (Option 7). AGN is the sole distributor in South Australia and the Northern Territory, so no postcode review is necessary for this state/territory (as long as the property is connected to natural gas).

In New south Wales, AGN operates the natural gas network in Wagga Wagga and in towns south of Wagga Wagga (the Wagga Wagga network is pictured below). AGN also operates the natural gas network in Albury and around other Riverina towns, including Finley and Moama. All eligible postcodes in NSW are listed in Table 1, however, to confirm eligibility for rebates/cashbacks, contact AGN’s Natural Gas Marketing Team on 1300 001 001 (Option 7).

Table 3: Postcodes where there are multiple distributors – Queensland.
